

ALB-Lu Cockpit 2009e - MENTAL OR PSYCHOLOGICAL MODULE

Illness shall mean:

A mental or behavioural disorder as listed in the Schedule of Permitted Mental or Behavioural disorders appended to this Policy

If the Insured becomes Disabled during the Period of Insurance as a consequence of an Illness defined in Schedule 2 of this Policy (Mental and Behavioural Disorders Permitted in respect of Temporary Benefit only) then the Insurer will pay 24% of the Lump Sum Benefit shown in the Schedule.

Temporary Benefits Period: The period for which Temporary Benefits can be paid. In respect of Illness falling within the illnesses specified in Schedule 2 this period cannot exceed 12 months. In respect of Bodily Injury or any Illness not specified in Schedule 2, this period cannot exceed 24 months and payment will cease if a Lump Sum Benefit is paid.

Periods for which Temporary Benefits are paid and which result from the same or a related Disability will be added together for the purposes of assessing whether the Maximum Benefit Period has been reached.

Any sum previously paid or due in respect of the Temporary Benefit section of this Policy will be deducted from any amount payable under the Lump Sum Benefit section of this Policy for the same or a related medical condition.

All other points from the "ALB-Lu Cockpit 2009e " such as waiting times etc remain fully valid
